
The 2018 annual conference

The seventh Housing LIN Conference, our sector showcase, took place at the KIA Oval, London in March. Such was the interest that all 300 places for 'Housing for All Ages' went in the first two hours.

Key speakers included **Helen Hayes MP** outlining the Housing, Communities and Local Government select committee's report on the need for a housing strategy for older people; **Professor Jeremy Myerson** from the Oxford Institute of Population Ageing talking about the role of quality design; and **Geeta Nanda**, chief executive of Metropolitan Thames Valley, who gave an inspiring talk on the role of sector leadership in meeting customers' needs and aspirations.

An international flavour was injected by **Dr Bill Thomas** from The Green House Project, an American project pioneering collaborative living.

Age-Friendly Housing report: Future design for older people



This RIBA publication, co-written by Julia Park of Levitt Bernstein Architects and myself, raises the bar for the design of housing for an ageing population and features the latest thinking and examples of mainstream and specialist accommodation with older people in mind.

Emphasising the importance of anticipating the needs and aspirations of the next generation of older people - and what this implies for our communities, towns and cities - our book shows how well-designed buildings can support the provision of care and support independence and wellbeing while providing companionship and stimulation.

HAPPI 4 Rural Housing for an Ageing Population: Preserving Independence

The Housing LIN has had a key role supporting each of the previous three inquiries by the All-Party Parliamentary Group for Housing and Care for Older People (APPG). It was no different when the APPG conducted its fourth inquiry, focussing on the particular housing needs and challenges of older people living in rural areas.

The report suggested an adaptation of the HAPPI principles when designing new homes for older people in rural areas, noting that new housing could preserve independence for older people and save NHS and social care funds. All the HAPPI reports can be found on the Housing LIN's Design Hub.



The Housing LIN's evidence to the MHCLG select committee on housing for older people

When the select committee published its report on older people's housing in early 2018 it called on ministers to develop a strategy.

In my oral evidence, I highlighted the need for more information and advice for older people thinking about their future and a general shortfall of around 400,000 units of ageappropriate housing. A copy of our written submission can be accessed at: Housing LIN Select Committee Written Evidence.

We have also recently extended our presence into Scotland, developing a similar networking approach as with Housing LIN Cymru. We were delighted that **Helena** Herklots, the new Older Person's Commissioner for Wales was our keynote speaker at our Welsh symposium last November. She has since published her strategy to make Wales the best place in the world to grow older.

Our ambition is to be the UK's 'go to' practitioner network for sector innovation and improvement and to influence the housing and care market for older people and people with long term conditions.

We also want to grow our services and enable you to connect more effectively, engage with us and be involved in our national and regional programmes. Building on our reputation for high quality advice and assistance, we will also strengthen the intelligence and insight we offer our sponsors and strategic partners providing commercial & business information to help them transform their services (see examples of our consultancy activities on page 9).


Influencing and networking

As the influencing and networking lead for the Housing LIN, 2018 has been a busy and varied year for me. Our small but growing team in 2018 has helped strengthen our output in a variety of ways: our capacity to communicate with members, our impact, and our profile as a leading centre of excellence in housing and care across all ages.

Highlights have included:

- Invitations to 10 Downing Street, Cardiff and Holyrood; and opportunities to work with key partners across England, Scotland and Wales to inform important regional agenda, including that of the Greater Manchester Health and Social Care Partnership.
- An online 'home from hospital' map, developed with Foundations UK, showcasing where housing organisations are providing targeted support to get people home from (or prevent admission to) hospital. Home from Hospital Tool
- A focus on housing inequalities faced by older people from Black and Minority Ethnic backgrounds, culminating in the publication of an important review of the evidence, commissioned by the Housing LIN and the Race Equality Foundation. Housing and the older ethnic minority population in England
- A 'Grand Challenge on Ageing' event exploring future housing solutions to support healthy ageing. Hosted by the Department of Health and Social Care and the Department for Business, Innovation and Skills, and chaired by the Housing LIN, the discussion resulted in a well-received report. Innovative Housing Models for an Ageing Population
- A report exploring the reasons for the relatively slow progress of technology and digital in housing and care, and identifying some hopeful pointers for the future. Technology and Digital Connected Care Services: Towards the tipping point?

Underpinning your progress

We can look back on 2018 as the year that the Housing LIN's research and consultancy services became successfully established.

Encouraged by our stakeholders, we provided a comprehensive service to commissioners and providers operating in the older people's and supported housing sectors. We worked with numerous local authorities; for example, through the Local Government Association's Housing Advisor Programme, undertaking market analysis, demand assessment and supporting the development and implementation of practical delivery programmes to widen housing choices for older citizens.





We have also worked continuously over the last year with social landlords, large and small in all areas of England and Wales. From strategic reviews of extra care housing, sheltered housing, retirement villages or almshouses to resident engagements, we have provided expert assistance with rethinking and remodelling housing assets and associated services to provide a more relevant and attractive offer to their older and more vulnerable customers.

And through our work with NHS England, we have assisted over half a dozen NHS and local authority Transforming Care Partnerships to develop meaningful plans and delivery strategies to support people to move from institutional living to have a home in the community. In addition, we have been asked by many of these local partnerships to support them to better understand the housing requirements of the wider population of people with learning disabilities and facilitate plans to widen their access to housing opportunities.

The sheer diversity of our research and consultancy activity reflects the Housing LIN's influence across multiple environments; including:

Our evaluation of The Guinness Partnership's innovative approach to making their entire business dementia-friendly (see testimonial, page 10). Independent Evaluation of The Guinness Partnerships Dementia Project.

Our work for Mencap to research the complex area of funding for specialised supported housing and its role in brokering housing for people with complex needs: Funding supported housing for all Specialised Supported Housing for people with a learning disability, and our work with the charity KeyRing to develop a new financial proof of concept for their innovative approach to community support: Establishing the financial case for KeyRing.

From our work, it is clear that many Funding supported housing for all housing providers are seeking to address questions about who their future customers will be, what they will want and how best to meet the growing diversity and aspirations of current and future customers' requirements. Answering these questions requires a blended mix of customer intelligence along with hard data analysis to provide clarity and insights to support informed strategic decision making. Drawing on our extensive experience, tools and skills, the Housing LIN is extremely well placed to underpin your progress.



In 2016, Guinness Partnership embarked on a project around becoming a dementia friendly housing organisation, this was a high priority for us, and we wanted to get it right first time. We got a thorough well written evaluation that accurately reflected what we had done. They also provided us with recommendations for the future, picked out from not only their work with us but their broad understanding of the wider sector. They were willing to allow us the



freedom to layout the report as we chose through our internal communications team thus giving us a report that matched the look and feel of Guinness Partnership.

The team at the Housing LIN were professional, accommodating and easy to work with, really going that bit further to help Guinness Partnership on the way to becoming a dementia-friendly organisation.

Our key work areas for 2019

In 2019, we will continue to strengthen our member and partner relations, focus our influence and research on essential issues facing the sector, and further develop our consultancy activities, as follows:

Our members

Currently standing at over 25,000 members, in 2017/18 we increased our membership by 12% on the previous year, and in 2019 we fully expect to surpass this rate of growth. This will be supported by a successful programme of regional events, as well as by our continued focus on ensuring the Housing LIN website is the essential online home for all the latest news and analysis for the housing with care, housing and health, and supported housing sectors.

Two particularly exciting areas of development stand out:

- The newly established Housing LIN Scotland network, alongside the flourishing Housing LIN Cymru, both of which will play an increasingly productive role in enabling effective information and knowledge sharing in their respective regions.
- A new programme of work to put a new focus on the next generation of Housing LIN members - supporting young leaders from across housing, health and care to network, access peer support, and develop their skills in multi-disciplinary and partnership working.

Our new business

We expect a growing trend for local authorities and their partners to take a renewed interest in all types of supported and specialist housing; we are currently working for several local authorities and their partners seeking to rejuvenate and set new standards in terms of the quality of housing provision available for people with support needs: from people at risk of homelessness to people requiring highly adapted properties.

We also expect to build on our recent track record of working with local authorities and housing providers in Wales and Scotland in relation to housing market analysis and service review and remodelling; for example, our work with the Greater Manchester Health and Social Care Partnership to assess need for housing for people with learning disabilities and developing an extra care housing resource pack.

Our influence

We confidently expect the Housing LIN's influence and reach to continue to grow. With our unique access both to policy and research expertise, and local practice knowledge and experience, the Housing LIN is ideally placed to support the learning and understanding of all our members, stakeholders and partners.

We will be giving evidence to two different All Party Parliamentary Group sessions at Westminster in May, as well as offering ongoing engagement with DHSC and other key partners on the themes of the adult social care Green Paper. In these and many other ways, the Housing LIN will continue to play an influential role in informing the thinking of the UK's policy makers, shapers and decision makers across housing, health and care.

And on the research front, we are delighted to have teamed up with universities to support different aspects of housing and ageing research into practice. They include:

- - University of Bristol's School for Policy Studies' ESRC funded 'Diversity in Care Environments' (DICE) in England and Wales project, and if successful,
- University of Stirling and partners' led bid on 'Scaling up Innovation in Housing with Older People' and
- University of Newcastle's project on 'The Market for Accessible and Adaptable Homes'

Our thought leadership

And finally, we will be offering thought leadership and enabling top class knowledge exchange on a selection of important topics. They include:

- The role of housing in the social care green paper and links with the NHS Long Term Plan
- The housing needs and aspirations of people with learning disabilities
- Making the most of the potential benefits offered by digitally enabled care and housing services

REUBEN HASTINGS




