

NEWS UPDATE

The Housing LIN welcomes the Government White Paper Our health, our care, our say: a new direction published on 30 january 2006 (read or download 236 pages http://www.dh.gov.uk/assetRoot/04/12/74/59/04127459.pdf).

The White Paper has a number of useful references and examples of Extra Care Housing. It also makes the link with wider housing and related preventative care and support services such as telecare, the work of Home Improvement Agencies, and aids and adaptations.

The key elements in the White Paper are:

- 1. Our ambition for community-base care
- 2. Enabling health, independence and well-being
- 3. Better access to general practice
- 4. Better access to community services
- 5. Support for people with long-term needs
- 6. Care closer to home
- 7. Ensuring our reforms put people in control
- 8. Making sure change happen
- 9. A timetable for action

TELECARE UPDATE

The Preventative Technology Grant allocations to support the implementation of telecare between 2006 and 2008 are now available. The allocations will be made to social services departments. Organisations across England should already be working together on the implementation arrangements for their local areas to ensure the best use of these new resources.

A Department of Health circular will follow in March 2006 to take forward the approach outlined in 'Building Telecare in England' which was published in July 2005.

The White Paper recognises the importance of assistive technology in supporting people safely in their homes using telecare and telehealth services It also recognises the importance of integrated working. Further work will be done to establish the effectiveness of remote monitoring over the next two years. The relevant sections of the White Paper 5.36 to 5.42.

A national framework agreement for telecare is expected to commence in June 2006. The work is being led by the NHS Purchasing and Supply Agency (PASA). The advantages of this type of procurement framework for organisations who commissioning, purchasing and providing telecare and telehealth services are potentially enormous. Organisations using the framework (local authorities, health trusts, independent and voluntary organisations) will be able to significantly reduce their procurement and purchasing timescales providing potential savings in duplication, product and service costs as well as making preventative services available to a wide range of service users and carers more quickly. Another significant benefit will be that all the suppliers on the agreement will be working to a set of standard terms and conditions.

EXTRA CARE TRAINING AND WORKFORCE DEVELOPMENT

In partnership with <u>Asset Skills</u>, the Housing LIN is working with Management and Performance Solutions (<u>MAPS</u>) to undertake detailed a training needs audit of SME providers of housing for older people in the West Midlands. This work will assess the skill levels and requirements required in extra care housing. MAPS have been successful in a

£40,000 attracting a Business Link grant to help develop our work on National Occupational Standards (NOSs) for housing, care and support and development staff working within an extra care setting. The guidance will identify the shared policy and practice issues for developers and service providers and advise on the assessment of data and the coordination of development proposals, implementation and subsequent management. It will include detailed recommendations for the preparation of relevant supplementary planning documents, in particular, for Extra Care Housing.
