ADULTS' PERSONAL SOCIAL SERVICES: SPECIFIC REVENUE GRANT AND CAPITAL GRANT ALLOCATIONS FOR 2013/14 & 2014/15

SUMMARY

1. This letter is issued to local authorities to announce their provisional adults' Personal Social Services (PSS) specific revenue and capital grant funding for the period 2013/14 and 2014/15. Details of individual funding stream allocation formulae (where these are available), and a brief description of each area, appear in the relevant annexes.

ACTION

2. This letter is provided for information only, and provides details of provisional local authority allocations for 2013/14 and 2014/15.

SPECIFIC REVENUE FUNDING

Changes resulting from the Business Rates Retention scheme

- 3. In previous years, DH allocated the Learning Disability and Health Reform grant to local authorities. In 2012/13, this was made up of four streams: the Learning Disability Transfer; Blue Badge funding; funding for Deprivation of Liberty Safeguards in Hospitals; and start up funding for Local Healthwatch.
- 4. From 2013/14, the Department for Communities and Local Government is introducing a Business Rates Retention scheme, under which local authorities will retain a proportion of the business rates they collect. Local authorities will be able to increase their income by growing their local economies and collecting more business rates.

5. To maximise the growth incentive, a number of specific grants from other departments have been transferred into this scheme – including the Learning Disability and Health Reform Grant. Local authorities will still receive funding for all of the responsibilities covered by this grant, and this funding will be clearly identifiable in the local government finance settlement tables for each of the local authorities in receipt of this grant.

Local Reform and Community Voices Grant

- 6. In 2013/14 and 2014/15, DH will make around £42 million and £43 million respectively available through the new Local Reform and Community Voices Grant. This grant is comprised of five funding streams:
 - additional funding for Deprivation of Liberty Safeguards (DOLS) in Hospitals;
 - additional local Healthwatch funding;
 - funding for the transfer of Independent Complaints Advocacy Service (ICAS) to local authorities;
 - funding for the transfer of Independent Mental Health Advocacy (IMHA) to local authorities; and
 - funding for the veterans Guaranteed Income Payments (GIPs) social care charges exemption.
- 7. The Government has consulted on how funding of each of these streams should be allocated to local authorities. The purpose of the funding streams, and the allocation methodologies used, are explained in **Annex D**.
- 8. A breakdown of the national grant total by funding stream is included at **Annex A**; and provisional local authority allocations are at **Annex B**.

CAPITAL FUNDING

- 9. DH allocates the Community Capacity Grant to local authorities, providing capital funding to support development in three key areas: personalisation, reform and efficiency.
- 10. Capital grant funding has been held constant in real terms for 2013/14 and 2014/15. This means that local authorities will receive DH capital grant funding of £129 million for 2013/14 and £132 million for 2014/15.
- 11. The distribution uses total adults social care relative needs formulae. Provisional local authority allocations for 2013/14 and 2014/15 are set out in **Annex C**.

FURTHER INFORMATION

- 12. The Isles of Scilly no longer receive their main revenue support grant through the same process as other authorities. Full details of this are available in the CLG guidance. Where Department of Health (DH) specific grants are allocated using the relative needs formulae (RNFs), this will continue to apply to all authorities including the Isles of Scilly.

REVENUE GRANT - LOCAL REFORM AND COMMUNITY VOICES GRANT

<u>Assessment and authorisation of Deprivation of Liberty Safeguards (DOLS) in hospitals</u>

Overview

From April 2013, local authorities will have a new duty to make assessments and authorisations of DOLS in hospitals. We have provided additional funding for these new DOLS processes. These include:

- Assessing the nature and extent of deprivations of liberty that are appropriate on a case-by-case basis.
- Authorising deprivation of liberty where appropriate.

In 2012/13, we made £1.35m available through the Learning Disability and Health Reform grant to help local authorities to prepare for the transfer of the responsibility for authorising and assessing DOLS in hospitals. From 2013/14, this amount will continue to be paid out through the Business Rates Retention scheme.

In 2013/14 and 2014/15, we will be providing additional money to fund DOLS processes through the new Local Reform and Community Voices grant. Please see the table below for the provisional funding to be allocated for DOLS in hospitals:

Basis of Distribution

We published our response to the consultation on funding for DOLS in health care settings in December 2011¹. It confirmed that it would be allocated using the adult social care relative needs formulae (RNF) and that there would be a minimum allocation of £2,000.

Funding for DOLS in healthcare settings is provided through two separate funding streams: the old Learning Disabilities and Health Reform grant, which has now been rolled

into the DCLG Business Rates Retention Scheme (BRRS) and the Local Reform and Community Voices grant. Both funding streams will be allocated using the adult social care relative needs formulae. However, the minimum allocation of £2,000 is provided to local authorities through the BRRS funding. There is, therefore, no minimum allocation for DOLS funding in the Local Reform and Community Voices grant.

Additional local Healthwatch funding

Overview

From April 2013, Local Healthwatch will be the new consumer champion for patients and the public in health and social care. Local authorities will provide funding to their local Healthwatch for the new information and signposting services.

In 2012/13, we allocated local authorities £3.20m under the Learning Disability and Health Reform grant. This was to cover the set-up costs of local Healthwatch. This money will continue to be allocated as part of the BRRS.

In 2013/14 and 2014/15, we will be providing additional funding for local Healthwatch through the new Local Reform and Community Voices grant. Please see the table below for the provisional total additional funding to be allocated for local Healthwatch:

Basis of Distribution

We published our response to the consultation on funding the provision of information and signposting services through local Healthwatch in December 2011². It confirmed that we would use the adult social care relative needs formulae (RNF) and that there would be a minimum allocation of £20,000 to each local authority.

The new funding for local Healthwatch will be provided through two separate funding streams: the old Learning Disabilities and Health Reform grant which has now been rolled into the DCLG Business Rates Retention Scheme (BRRS) and the Local Reform and Community Voices grant. The BRRS funding has a minimum allocation of £10,000 to each authority. To ensure that each local authority receives at least £20,000 from this new funding, the minimum allocation for local Healthwatch funding through the Local Reform and Community Voices grant is also £10,000.

NHS Complaints Advocacy

Overview

Currently the Independent Complaints Advocacy Service (ICAS) provides complaints advocacy support to people who wish to make a complaint about the service that they have received from the NHS. From April 2013, responsibility for commissioning NHS complaints advocacy will pass from the NHS to local authorities.

In recognition of these additional responsibilities, we will be providing additional funding through the new Local Reform and Community Voices grant. Please see the table below for the provisional funding to be allocated for NHS complaints advocacy:

Independent Mental Health Advocacy (IMHA)

Overview

From 1 April 2013, local authorities will have a duty under the Mental Health Act 1983 ('the Act') to make arrangements to enable every qualifying patient who wants one to have access to an Independent Mental Health Advocate (IMHA). Qualifying patients include most of those liable to be detained under the Act, all patients on supervised community treatment, all patients subject to guardianship under the Act and a few others who are being considered for certain specified treatments for a mental disorder.

In recognition of these additional responsibilities, we will be providing additional funding through the new Local Reform and Community Voices grant. Please see the table below for the provisional funding to be allocated for IMHA responsibilities:

Guaranteed Income Payments (GIPs) disregard

Overview

From October 2012, GIPs for veterans injured on active service, made under the Armed Forces Compensation Scheme, are disregarded from social care charging.

In recognition of the cost of this exclusion to local authorities, we will be providing additional funding through the new Local Reform and Community Voices grant. Please see the table below for the provisional funding to cover the GIPs disregard:

CAPITAL GRANT - COMMUNITY CAPACITY

Overview

Capital funding will enable continued capital investment to support delivery of adult social care services (for example for AIDS/HIV services) and in particular community capacity.
