#### **BUILDING THE FOUNDATION: TAKING EXTRA CARE**





With an impressive cast of keynote speakers, session leaders and chaired by Jeremy Porteus, the 300 delegates were treated to the latest in research, policy, practice and innovative product developments.

Housing LIN and ADASS, he gave an impressive account of how commissioners and providers need to up their game in order to respond to the housing needs and aspirations that older people want (go to p.4 for details on SHOP).

Lord Best provided an overview of the findings from the recent APPG on Housing and Care for Older People 'Living Well at Home' Inquiry; highlighted the potential impact of welfare reform proposals, especially

in relation to HB; challenged delegates' thinking about the state of the market for purpose-built, welldesigned and affordable accommodation to enable older people to live well at home; and called for a greater choice and diversity of provision.

## **POLICY & FUNDING NEWS**

Other policy and funding news across housing, health and social care since our last enews includes:

#### **Housing & Ageing Alliance**

The Housing LIN is delighted to be invited to join the Housing & Ageing Alliance (HAA) and to host the HAA website. Details about its objectives to bring about improvements to the housing and living conditions of older people, a list of members and its recent response to the government's Caring for our Future consultation can be found at: www.housinglin.org.uk/HAA

#### NHS Operating Framework

The Department of Health have published the NHS Operating Framework for 2012/2013. This sets out the planning, performance and financial requirements for NHS organisations and the basis on which they will be held to account. It seeks to achieve better outcomes for patients and a growing importance of high-quality services but largely based on clinical decision making and integrated care for patients and service users.

While there is reference to community equipment, adaptations and telecare, it is disappointing to note that there is no mention of housing or any encouragement to engage and partner to develop or sustain innovative housing solutions that make a difference to the lives of those very same patients and service users.

Commenting on the framework, Jeremy Porteus said: "it makes me wonder who does the NHS actually want to integrate with - itself? Unless we can look beyond the vertical integrated structures that dominate the health landscape in primary and secondary care, housing, and even social care, will be left horizontal, with nowhere to rise."

#### Local government funding settlement and autumn statement

The lack of any 'quantitative easing' in the sector became a reality as the government announced that social care authorities will have £1.5bn taken out of their budgets next year. This is likely to put further pressure on councils at a time of unprecedented demand for care and support services. #### Oversight of user choice and provider competition in care markets

This report by the Parliamentary Public Accounts Committee puts the spotlight on the delivery of personal care and the potential for care market failure. It highlights that there are risks to the future functioning of the social care market from local authority budget reductions. It explains that social



care homes face inevitable increases in costs at the same time as local authorities inevitably reduce what they will pay to fund places. It also notes that 63% of funding of care comes from the public purse and suggests that reducing this funding could create some degree of pressure in the market. ## Bank fined for mis-selling long term care products

The Financial Services Authority (FSA) have fined HSBC £10.5m for mis-selling products to elderly customers to meet their long term care costs. It is reported that, in some cases, a former subsidiary of the bank offered individuals five-year investments which were longer than their life expectancy. #### Welfare Reform and Housing Benefit

At the time of going to print, Lord Best was tabling a housing benefit amendment to the Welfare Reform Bill which called for working age social housing tenants to be allowed to have one spare room before any restriction would apply, eg for health reasons. This exemption is already accepted for older and disabled tenants. The Housing LIN, supported by Bramalls and Greenwood Solicitors, will be publishing a detailed paper in early 2012 on the proposed changes and wider implications of housing benefit on extra care housing. Details to follow.

## Social Services revenue and capital allocations announced

The DH have issued a letter to councils in England confirming revenue and capital allocations for 2012/2013. In total, £1.4b revenue grants and £127m for capital purposes will be given to councils for the coming year. The capital component could provide a further boost to extra care housing where councils are seeking to transform local services, especially where the capital is used to support them deliver personalisation, reform and efficiency. **New DH funded extra care scheme opens**The official opening of the following DH funded scheme took place last month

## Cherry Tree Gardens, Houghton-le-Spring, Sunderland

Cherry Tree Gardens, a new development built by Gentoo Group was officially opened by the new Mayor of Sunderland, Councillor Norma Wright last month.

Partly funded by a £1.48 million DH grant to Sunderland City Council, this extra care scheme is part of a joint venture that forms part of the Sunderland City Councils Extra Care Housing Programme and the Gentoo Homes Renewal Programme. The development also received over £2m in funding from the Homes and Communities Agency (HCA).

It is targeted at people over 55 with a care or support need. Offering 40 self contained apartments, it provides independent living within community based surroundings, enabling people



to access care and support tailored to meet their individual needs.

The scheme also provides a restaurant and hairdressers, both of which are open to the wider local community. There is also a lounge, laundry, healthy living suite, guest room, multi purpose room and landscaped gardens.

Sunderland City Council will provide reablement accommodation from four of the apartments - freeing up hospital beds in the process.

In addition, residents moving in to 7 extra care bungalows from the adjacent PassivHaus development at Orchard Place, Hutton Rise, will also benefit from the full range of services provided by the scheme. To coincide with the Government's Housing Strategy and a 'deal for older people's housing', this new Strategic Housing for Older People (SHOP) Resource Pack offers a sector-led approach to meeting the housing demand and supply challenges for an increasingly ageing population. Speaking at its launch, Jeremy Porteus



stated, "there is an urgent need to embrace 'agefriendly' housing options that can meet the needs of increasing numbers of older people who want to live independently in the community. The rewards will include greater choice and independence for older people with well-designed specialist housing and neighbourhood amenities

To deliver on this, we need a radical rethink of how funders, planners, commissioners, developers and providers must deliver housing that older people want and make best use of our available resources."

Published by the Housing LIN, supported by the Association of Directors of Adult Social Services and written by the Institute of Public Care (IPC) at

Oxford Brookes University, the SHOP Resource Pack replaces the Housing LIN's Extra Care Housing guide. It now provides a framework and a basket of new tools for councils, public and private sector developers and providers to develop their strategic market position and take the initiative in designing and building homes that older people want, including extra care housing. These papers and tools support a variety of activities including:

- how to develop an understanding of what future demand is likely to be for housing for older people
- what does the market look like now and how should it look in the future

#### **Extra Care Housing independent evaluation**

The Personnel Social Service Research Unit (PSSRU) and Housing LIN have jointly published the evaluation of the Department of Health's Extra Care Housing Fund. The summary report, *Improving* housing with care choices for older people: an evaluation of extra care housing, provides a



comprehensive summary of the review of 19 of the schemes funded between 2004 and 2006 and details the key findings on improving outcomes, achieving greater care efficiencies and cost effectiveness and delivering more qualitative factors around improvements to older residents' wellbeing. It found:

Thomas Pocklington Trust have launched a new tool which tests how well housing performs for older people with sight loss and highlights which areas can be improved. In developing EVOLVE for Vision with the University of Sheffield School of Architecture, their survey found that only two scheme were designed

#### **TELECARE UPDATE**

This section highlights relevant Telecare and Telehealth items that may be of interest

#### 3 Million Lives can be supported

Hot off the heels of the NHS Operating Framework, this paper gives early findings of the DH's Whole System Demonstrator (WSD) projects and points out not only the system 'dividend' telecare and telemedicine can achieve but the benefits to the quality of patients and carers lives. For example, it reports that if used correctly, telehealth can deliver:

- a 15% reduction in A&E visits
- a 20% reduction in emergency admissions
- a 14% reduction in elective admissions
- a 14% reduction in bed days and
- an 8% reduction in tariff costs.

It also demonstrate a 45% reduction in mortality rates. On the back of this, the government has set out an ambition to extend the use new and emerging healthcare technologies to 3million people over the next 5 years. #### Into orbit with AT

Coventry University's Cogent Computing Applied Research Centre has teamed up with Orbit Heart of England housing association, TyneTech and Cirrus Communications to research the relationship between Assistive Technology (AT) and older people. The partnership is dedicated to enhancing and understanding the effective deployment of AT.

Dr John Halloran of Cogent explained, "The project is about understanding the human context of AT.



It is not just fit and forget like a smoke alarm. It needs awareness on the part of the residents and careful stewarding by staff. We want to find out more how residents and staff feel about AT; how far they accept it; their perceptions of need, and even their emotional responses."

Sue Garwood reports that Riversmeads Housing Association's flexicare housing scheme, Bircherley Court in Hertford, has been officially opened by Mark Prisk MP, Minister of State for Business and Enterprise. The £8.2m scheme comprises 70 one and two bed flats. It features a doubled height, glazed atrium and communal facilities including a roof top garden, bathing spa, hair and beauty salon and internet area. It provides tailored care and support on site 24 hours a day, to meet its residents' changing care needs.

Libby Spencer and Jean Bray report the NW councils are planning a series of transformation events, including one on extra care housing.

#### Yorkshire & Humberside

Paula Broadbent reports that Bramall construction and Greenwood Solicitors have joined forces to produce a Housing LIN Viewpoint on extra care and HB. This will be available in early 2012. Details to follow.
